Guest Speaker:

The Guest Speaker **Mr. John McDougall** was formally introduced by Roger Russell, as being a native Edmontonian, an engineer, President & CEO of the Alberta Research Council Inc.

His *Power Point* presentation was based on the theme "The Journey to a Sustainable Alberta Economy

The **ARC** was established in 1921 by the Government of Alberta and was the first of its kind in Canada; its prime aim was to facilitate the U of A to enter into research.

The ARC currently employs 500 people. One third PhD holders, one third Engineers and one third Support personnel

Has a budget of \$91 million one third of which comes from Government.

It provides "Technical Services", "Strategic R & D" & "Technology Commercialization"

Examples of Work in Progress:

- ARC & FORINTEK the primary innovation of turning "Aspen" into a multi billion dollar value added resource.
- ARC helped CERAMIC PROTECTION CORPORATION in the development of:
 - 1. Ballistic ceramic plates used in personal, vehicle and structural armour systems.
 - 2. Revenues grew from \$4M in 1999 to \$33M in 2004
 - 3. Employ 40 people in Calgary.
 - 4. 95% of sales are exports.
