President Ken Burnett was welcomed back from his winter retreat in Yuma. Roger Russell introduced his guest, Andy Frederickson.

Dick Ogilvie introduced the guest speaker, Mr. Derek Mather, President and Chief Executive Officer for Vencap Equities. Mr. Mather, a westerner and a graduate in economics of McGill University, was appointed President when the Vencap Equities concept was introduced in 1981.

The basic idea was to provide a loan fund for small businesses in the private sector, because there was a shortage of venture capital. An ad hoc committee under Chairman F.N. Hughes (now the Chairman of the Board) spent two years in organizing Vencap.

It was eapitalized by a share offering to the public of \$44,000,000, which has been fully subscribed, and a loan of \$200,000,000 from the Heritage Trust Fund for 30 years at a favorable interest rate.

Certain principles in the articles of incorporation were established. There was to be no government ownership; no loans for the oil and natural gas industries; and no loans for real estate development. On the positive side loans would be available for small businesses with potential for substantial growth; loans to support the expansion of existing businesses; and loans for companies wanting to buy other companies who in wish to sell. The speaker explained that the types of businesses Vencap would encourage

were in the fields of transportation, technology, science, manufacturing, and research. One of the first major loans made was to a Peace River company engaged in catering and transportation.

Hitherto, said Mr. Mather, capital was available only in Central Canada and United States; but now Vencap Equities will play an important role im expanding business opportunities in Alberta, and indeed Western Canada; and this will provide a much more diversified economic base in this part of Canada.

A question period followed.

Al McClure thanked the speaker for his revealing talk on the organization, principles, and effects of Vencap or our economy.
